SECTION 2 - HAZARDS IDENTIFICATION

<u>Dark Shades</u>: Water, Propylene Glycol, Isopropyl Myristate, Mineral Oil, Talc, Stearic Acid, Cetyl Palmitate, Polysorbate 60, Glyceryl Stearate, Fragrance, Eucalyptus Citriodora Oil, Magnesium Aluminum Silicate, Triethanolamine, Trisodium EDTA, Imidazolidinyl Urea, Camphor, Xanthan Gum, Menthol, Eugenia Caryophyllus (Clove) Flower Oil, Propylparaben, Methylparaben, Titanium Dioxide, Iron Oxides, Ultramarines.
